IMPORTANT NOTE FOR STALLHOLDERS - no vehicles are to enter, park or unload in the “drop-off” quadrangle in the centre of the hotel under any circumstances (there is no direct access to the hall from this area). This is a Health & Safety requirement and the hotel WILL REMOVE any vehicle from this area. Anyone failing to adhere to this condition will be denied entry to Photographica as we have been informed that it will jeopardise our future bookings.

Stalls will be allocated in a first come, first served basis. In a new venue we obviously cannot offer positions “as last year”. We will, however, do our best to offer positions similar to last year in relation to other stalls, and if you have any particular requirement, for example, being next to a particular stallholder, or on the end of a row, please let us know and we will do our utmost to accommodate you.

CONDITIONS OF PARTICIPATION

1. Photographica 2024 is organised specially for the buying, selling or exchange of any photographic item. Please do not bring watches, phones, or other non-photographic items for sale.
2. Stallholders will be notified of setting up times and table numbers approximately two weeks prior to the event. **Please note that special positions cannot be guaranteed.**
3. Stallholders are advised that they are entirely responsible for the security of their goods and that neither the organisers nor the Royal National Hotel shall be held responsible for any loss or damage to their property whilst on the premises, however caused.
4. **Stallholders must ONLY enter or exit the hall via the hotel loading bay** (adjacent to Bloomsbury Lanes bowling alley at the top of Bedford Way) and should queue from there down the length of the hotel frontage. The loading bay gates are security controlled and a PCCGB representative will have the access code to open them at 08:00. In the event of rain, it may be possible for stallholders to queue under cover inside the loading bay. **There is NO vehicle access to the hall from the underground hotel car park and stallholders using this facility must unload outside.**
5. Stallholders may not extend their stalls with extra tables, boxes, or racks etc.
6. One stallholder ticket and one helper ticket will be provided for each table booked. **Any misuse of tickets will result in refused entry and jeopardise the stallholders' future bookings.**
7. Neither the organisers nor the Royal National Hotel will be responsible for any transaction between stallholders, club members or members of the public, nor for any customs requirement for items brought into, or taken from, the UK.
8. Neither the organisers nor the Royal National Hotel shall be held responsible for any costs, claims, demands, or expenses arising from the cancellation or part-opening of the event due to circumstances beyond their control.
9. No item may be connected to the electrical supply for any purpose without prior arrangement, and any equipment brought into the hotel must have been tested and be safe to use.
10. Due to food hygiene regulations, no external food is to be consumed on site, and no alcohol can be brought onto the premises.
11. Bookings for the event are not transferable. Stallholders unable to attend will be refunded by the organiser provided they are informed by April 30th and the table can be re-let. The organisers reserve the right to re-allocate any table unclaimed half an hour prior to the public being admitted.
12. Tables are let on the condition that a reasonable number of items are displayed for sale. The organisers reserve the right to refuse future bookings if, in their opinion, this condition has not been met.
13. Stallholders must keep their stalls open until 4pm, except by prior arrangement with the organisers. Stalls must be cleared by 5.30pm.
14. Club members can only book one table at the members' rate. All other tables booked will be charged at the non-members' rate.
15. Your signature on the attached application form will be held as acceptance of the above conditions.
16. For those wishing only to buy, please note that a 'buyers early entry scheme' with entry ONLY via the North entrance of the hotel, will operate and will be allowed entry half an hour after the sellers. Please see application form for details.
17. Please ensure that nearby residents are not disturbed before 7am, and always keep noise to a minimum.
18. No trolleys are to be used in the hall between 10am and 4.00pm.
19. The organisers reserve the right to refuse any booking without explanation.
